SPECIAL INSTRUCTIONS TO THE PRINCIPALS

- The college login will be closed on 30-09-2024 by 5.00 PM.
- The late fee amount will be levied automatically in case the fee is not remitted to the O.U. A/c and forms are not submitted as per the above schedule.
- Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of Not Eligible candidates will be cancelled at any stage, if they write the examination

Fee Structure: -

- 1 LL.B all Courses of II-Semester Regular is Rs. 1265/- + Rs.150/- (Memo Charges) + Rs. 100/ (Biometric Fee) Total fee is Rs. 1515/-
- 2 LL.B all Courses of l-Semester Backlog & Improvement Exams Fee for all papers Rs. 1265/- + Rs.150/- (Memo of Marks) + Total fee is Rs 1415/-.
- 3 Upto two papers Backlog and Improvement Rs. 770/- + Rs.150 (Memo of Marks) = Total fee is Rs. 920/-.

Note: The Principals are requested to submit the II-Semester Internals award Lists of LL.B on or before 30-09-2024. Otherwise the college has to pay Rs.1000/- per day as Penalty for Late Submission of award lists.

Not to collect the Exam fee from Blind, Physically Disabled, Deaf & Dumb students as per O.U Order No. 1555/228/2007-08/Budget-V, dated: 25-03-2008. A Xerox Copy of Medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. Blind, Physically Disabled, Deaf & Dumb Students Application forms should be submitted separately along with Separate Nominal Roll.

Important Note:-

- 1. The Examination Application Forms (EAF) are to be submitted online through college login. Also, hardcopy of the same may be downloaded and must be kept with concerned college principal.
- 2 The concerned Principal's required to transfer the fee amount through the Application (Online payment options Net Banking or RTGS) only.
 - a. If the College makes the payment through online, there is no need to submit any document (for proof of Fee).
 - b. However, if the College makes the payment through RTGS/NEFT, they have to submit (1) Fee Abstract (Downloaded from the college login), (2) Download from College Login, Exam Branch, O.U.

CONTROLLER OF EXAM
