 Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of Not Eligible candidates will be cancelled at any stage, if they write the examination.

## NOTE:-

- 1. The students are advised to enclose Xerox copies of their qualifying examination certificate copies duly attested by the College Principal concerned.
- 2. The Principal is requested to send the <u>Faculty list</u> without which the examination forms will not be accepted.
- 3. The Principal is requested to verify the eligibility of the students thoroughly and forward the same to this office for the issue of Hall Ticket. If failed to verify the eligibility of the candidates, the principal is held responsible for the issue of hall ticket by this office to the non-eligible candidates.
- 4. The Principal may kindly forward all the examination application forms **online Through College login**

- 5. The Principal may kindly forward all the examination application forms along with the prescribed examination fee on or before 29-10-2024 together with Nominal Rolls.
- 6. The students who were transferred from the University Jurisdiction and other Universities their examination forms should be submitted separately with the Approval of the competent authorities like commissioner of Tech. Education, Govt. of T.S. and Director Academic Audit, O.U. with allotment of HT. No.s.
- 7. Not to collect the Exam fee form Blind/Physically Disabled Deaf & Dumb students as per O.U. Order No. 1555/228/2007-08 /Budget-V, dated: 25-03-2008. A Xerox copy of medical Certificate confirming their status. as handicapped (minimum percentage of disability must be of 40% attached to the application forms). Blind/ Physically Disabled, Deaf & Dumb Students applications forms should be submitted separately along with separate Nominal Roll.
